

NOTICE ON THE ELECTRONIC SURVEILLANCE SYSTEM OPERATED BY NATIONAL TOLL PAYMENT SERVICES PLC. AT ITS REGISTERED OFFICE AND IN THE CUSTOMER AREA OF ITS CUSTOMER SERVICE OFFICES

Dear Visitors and Customers,

The purpose of this notice — an annex to the notice on the processing (protection) of personal data (hereinafter referred to as the “Privacy Notice”) for users of the customer service offices of NTPS Plc. (“the Company”) and persons visiting or working at the Company’s registered office (H-1134 Budapest, Váci út 45. Building B, hereinafter: “the Main Office”), forming an integral part thereof — is to inform the customers and visitors of NTPS Plc. qualifying as data subjects about the data protection-related details of camera surveillance carried out in the Company’s customer service areas and its Main Office and the associated data processing activities of NTPS Plc. in a concise and transparent manner and using plain language. (The customers of NTPS Plc. and the persons working at or visiting the Main Office are hereinafter collectively referred to as “the Data Subject(s)”.)

The Company has installed **warning signs (pictograms)** in the monitored areas, indicating that cameras are being used.

By entering the customer service areas and the Main Office, the Data Subjects shall consent to the processing of their personal data captured by the camera system in accordance with the Privacy Notice.

Rules applicable to the operation of the camera system

- The legal basis for the application of the electronic surveillance system is legitimate interest under Article 6(1) point (f) of the GDPR and the interest pursuant to Section 5(1) point (c) of the Act CXII of 2011 on the Right to Informational Self-determination and on the Freedom of Information (“the Privacy Act”) (protection of the vital interests of the data subject or of another person, or the elimination or the prevention of a direct threat to the life, physical integrity or property of persons).
- The Company shall use the surveillance system for the protection of life, bodily integrity and property.
- The tools and methods used by the Company in the course of its surveillance activities shall not prejudice human dignity and privacy.
- The Company stores recordings captured by the cameras for 15 working days, thereafter the recording shall be destroyed, except where the data subject requests the blocking thereof.
 - The Data Subject may request blocking (restriction) of the recordings, it is sufficient to invoke his or her legitimate interest and there is no need to prove it. Turning to the authority is not the Data Subject’s only legitimate interest. The blocked recording may be stored beyond 30 days. If the Data Subject also requests a copy of the recording, he or she need not provide a reason therefor.

- The images captured by the electronic surveillance systems installed in the customer service offices of NTPS Plc. are recorded in secure (closed) server rooms of the respective sites.
- The Company shall hand over such recordings to third parties (e.g. the Police or Court) only in cases specified by the law. Recordings may only be reviewed in the event of suspected offences or crimes.
- The areas and premises surveilled by the Company are limited solely to those used by it, in accordance with the following table.
- No live images are captured in the customer service offices.
- The cameras in operation record images without sound.
- The Company does not operate hidden cameras and does not carry out surveillance in premises where such activities would infringe human dignity.
- The review of recordings shall be permitted solely to persons authorized to decide on the merits of the case based on such review.
